INITIAL RESOLUTION AUTHORIZING GENERAL OBLIGATION BONDS IN AN AMOUNT NOT TO EXCEED \$24,952,000

BE IT RESOLVED by the School Board of the School District of Hartford Joint No. 1, Towns of Addison, Ashippun, Erin, Hartford and Rubicon, Washington and Dodge Counties, Wisconsin that there shall be issued pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$24,952,000 for the public purpose of paying the cost of acquiring land and constructing and equipping a new elementary school facility including related site work; improving, adding to and renovating existing school facilities; and upgrading and replacing fixtures and equipment.”

RESOLUTION AUTHORIZING THE SCHOOL DISTRICT BUDGET TO EXCEED REVENUE LIMIT FOR FOUR YEARS FOR NON-RECURRING PURPOSES
