**QUESTION NUMBER I**

Shall the following Resolution be approved?

RESOLUTION AUTHORIZING THE SCHOOL DISTRICT BUDGET TO EXCEED REVENUE LIMIT FOR THREE YEARS (BY \$800,000 IN 2009-2010; \$1,200,000 IN 2010-2011 AND \$2,000,000 IN 2011-2012) FOR NON-RECURRING PURPOSES CONSISTING OF ONGOING OPERATIONAL EXPENSES

BE IT RESOLVED by the School Board of the Waupun Area School District, Dodge and Fond du Lac Counties, Wisconsin, that the revenues included in the School District budget be authorized to exceed the revenue
