

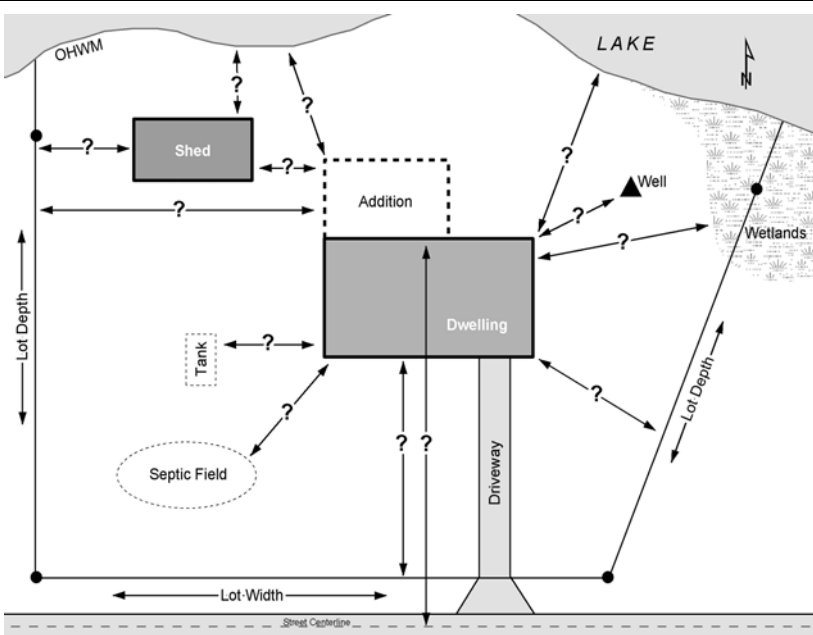

APPLICATION INSTRUCTIONS

1. Please use black or blue ink to complete this application form;
2. Fill in the **Name and Mailing Address** information for the applicant and owner and contractor's state certification number.
3. Fill in the **Property Description**, Parcel Identification Number (PIN) in the space provided. If your property contains more than one PIN number, please list all of the numbers. The PIN identification number is critical in the processing of this permit. Your PIN number can be found on your Tax bill or you may contact our office for assistance in finding your PIN number;
4. Complete the **Present Property Use** and **Proposed Property Use** sections. Choose the use(s) that best describes the current and proposed use of your property;
5. **Proposed Project(s)** space is provided for 2 projects, however, more may be accomplished on one application.
 - Principal Structures: Structure in which the principle use of the lot is conducted.
Examples: Home, commercial building, factory, restaurant/tavern, etc.
 - Accessory Structure: Any structure other than principle.
Examples: Fence, detached garage, shed, barns, silo, granary, boathouse, pool, etc. (*porches and decks are principle structure additions*)(*Agricultural structures require "Number of Animals"*)
 - Riprap: Additional supplemental forms must be submitted with this application (**Please contact office**)
 - Signs: Require additional information, a detailed side profile and lighting information.
 - Other: If not listed, please describe.
Examples: Wind turbine, antenna, water towers, grading, filling & dredging. (*NOTE, Most of these projects require additional information*). (**Please contact our office**).
6. Complete **Dimensions**, indicate whether the project is:
 - New, Addition or Repair: Additions may include; porches, decks, attached garage, dwelling additions (*Increase in bedrooms, please indicate #*).
 - Dimensions of the proposal: Length, width and area.
 - Height: Measured to the peak of said structure.
7. If the proposed project is a sign please complete "**Sign Addition Information**". (*Sign design & lighting plan required!*)
8. Provide an estimate of the cost of construction with labor included;
9. PLEASE NOTE: "The owner/agent is responsible to stake out the proposed project corners and the property corners. Failure to stake the project and the property corners will delay the issuance of this permit and may result in an additional inspection fee;
10. Attach a site diagram to this application in accord with the directions listed below;
11. Complete **Certification**, sign and date the application and provide a telephone number where you can be reached;
12. **Submit the application form, site diagram and appropriate application fee (Payable to Dodge County) to the address listed on the front of the application**

SITE PLANS AND BUILDING PLANS

- All applications must be accompanied by a site plan. Figure 1 below is an example of an acceptable plan.



Site plans must be drawn to scale and/or all dimensions given, such as:

- Location and dimensions of the project
- Location and dimensions of existing structures
- Dimensions of the property
- Location and names of abutting roads, lakes & Streams
- North arrow
- Owner's name

Distances must be shown from the project to:

- Lot lines
- Road right-of-ways & centerline
- Water bodies Ordinary High Water Mark (O.H.W.M.)
- Septic & holding tanks
- Soil absorption systems
- Nearby structures (within 50 feet)

Please Notify Appropriate Township Representatives or Government offices for any additional permit requirements
